Half Niche Package: A license to use one- half (1/2) of the niche space at the above assigned location in the Memorial Garden for the cremated remains of the one (1) person identified above, together with the items described below that are a part of this type of cremation niche package. The other half of the niche at this location may be licensed to another applicant. The urn for the first person to be interred will be placed to the rear of this space and the inscription for that person will be at the upper portion of the facing stone. If an existing half niche is available, it must be selected before a new niche is opened.

Full Niche Package: A license to use the full niche space at the above assigned location in the Memorial Garden for the cremated remains for the one (1) person identified above, together with the items described below that are a part of this type of cremation niche package. There will be no other use of that niche space or the facing stone.

Family Niche Package: A license to use the full niche space at the above assigned location in the Memorial Garden for the cremated remains of the two persons identified above who share the same family name, together with the items described below that are a part of this type of cremation niche package. The family name will be carved at the center of the facing stone.

Each cremation package includes a treated and polished cremation urn, an engraved brass urn plaque, opening and closing, a standard inscription on the facing stone and related administrative services. The Family Niche package includes these items for two people.

I have read and received a copy of this application, including the License for Inurnment and the current Memorial Garden Policies and Regulations. I agree to the terms of this Application, including the License for Inurnment, and the Memorial Garden Policies and Regulations as adopted from time to time. If this Application is approved, and in the case of a cremation niche package, the requested license is granted, there will then be a contract between us upon the terms contained in all of these items. I acknowledge that St. James the Fisherman Church has the right, at its sole discretion, to deny this application.
